CAPPING CELL10A

- Demonstrated the current capping process on Cell10A depicting the clay sampling for compliance conducted by PLC in conjunction with Ground Science.
- Shared feedback that SUEZ got from a new local resident about odour which led us to investigating the area by completing an odour run at the reported time of 5:00am. After making first hand observations mid-December resulted in two new wells to extract gas to be installed.

GENERAL LANDFILL OPERATIONS

- Informed about the success we have been having with SUEZ's Hallam Road protocol for managing the site during high wind events.

HALLAM ROAD UPGRADE

- Shared that success SUEZ had in collaboration with Vic Roads in regards to saving a 600 year old tree.
