

# ADD A VEHICLE | UPDATE VEHICLE DETAILS | REMOVE A VEHICLE **Commercial Credit Account**

1. Enter your SUEZ Account Name and Number
2. Indicate the action type and whether it is permanent or temporary - are you adding a vehicle to your account, removing a vehicle from your account, or amending vehicle details?
3. Enter the vehicle's rego and indicate the vehicle's configuration. If the vehicle has more than one possible vehicle configuration please insert rows and add these options.
4. If the vehicle is fitted with FUPS, or uses load share, please indicate in the FUPS and load share column.
5. If you authorise the vehicle to use a stored tare, please indicate.
6. Please include light vehicles (< 4.5 tonnes) that are authorised to tip on your account. These vehicles will have a mass limit of 4.5 tonnes.
7. If the vehicle can carry more than the standard mass limit (GML for NSW, VIC, QLD and SA; GVM for WA only), please attach the permit document to the email when returning this form; unless SUEZ are provided with evidence /documentation, the vehicle will be set-up with the GML (or, if in WA, with the GVM).
